House Passes Plan to Increase Pontiac Residents' Access to Higher Education

Plan allows students to use Promise Scholarship to repay locally funded tuition

LANSING - The Michigan House recently passed a plan sponsored by State Representative Tim Melton (D-Pontiac) that will allow students who receive the Michigan Promise Scholarship to use the funds to reimburse local programs that help fund their tuition.

"No student who wants to earn a higher education should be deprived of that opportunity simply because it's too expensive," said Melton, Chair of the House Education Committee. "Thanks to the Michigan Promise Scholarship, many students who used to dream of attending college are now making it a reality. However, not everyone can afford to pay the tuition it takes to get

started; this plan will make it easier to help those students achieve their higher education goals."

Currently, a Michigan Promise Scholarship totaling \$4000 is disbursed to an approved higher education institution on a student's behalf after he or she completes two years of community college, university or vocational training with a grade point average of 2.5 or higher.

"This bill gives communities a powerful

new tool they can use to help send their young people to college and to strengthen their local economies by focusing on the skills employers need." said Governor Jennifer M. Granholm. "This legislation helps us achieve one of our most critical goals - to give Michigan the best educated workforce in the nation."

Melton's plan aims to help students who do not have the money needed to initially finance their education and allows them to enroll in higher education with the intent to earn the Promise Scholarship in two years. Under the plan, students who qualify for the Michigan Promise Scholarship may instead assign their scholarship money to a local

Promise Zone Authority or a community foundation in order to reimburse the program for helping the student pay for the first two years of tuition.

"Passing this plan today demonstrates our commitment to higher education for all Michigan residents," Melton said. "By creating more opportunities for our students, Michigan will have the highly educated workforce it needs to make our state a powerhouse in the 21st century economy. I urge my colleagues in the Senate to take action on this plan and help turn our state around by giving our residents more access to the higher education they deserve."

Brooks Patterson thinks about running for governor

Oakland County Executive L. Brooks Patterson is considering whether to run for Michigan governor.

According to Columnist Nolan Finley with The Detroit News the 70-year-old Republican plans to announce Saturday that he's exploring a run for the governor seat in 2010. Democratic Gov. Jennifer Granholm can't run for a third term because of term limits.

Other possible GOP candidates include Secretary of State Terri Lynn Land, Attorney General Mike Cox, businessman David Brandon, U.S. Reps. Pete Hoekstra, Mike Rogers and Candice Miller and Oakland County Sheriff Mike Bouchard.

Possible Democratic candidates include Lt. Gov. John Cherry, Flint Mayor Don Williamson, Macomb County Sheriff Mark Hackel, Wayne County Executive Robert Ficano and former Michigan State football coach and current university trustee George Perles.

Remaking Of The Pontiac School District - Let's Get it right this time!

Let me first take this opportunity to thank all of you who have taken the time to read our humble publication over the past two years. We want to especially thank our advertisers, production and printing company, editors, sales people, contributing writers, paper folders (Erykah Chambliss, De'Angela Gibson, Macoya Midgett,

Tatyana Watkins) and distributors for your assistance in making sure that The Pontiac News continues to exist. Thanks to the people who took time out of their busy schedules to send words of encouragement to The Pontiac News. The overwhelming response to this publication since inception has been positive and encouraging and we do appreciate this great show of goodwill!

LET'S GET IT RIGHT THIS TIME!

The Pontiac Redesign Committee consisting of private citizens (myself included), State Rep Tim Melton, school board members, administrative, union and other district staff met over the last 3 months to study and discuss Pontiac School district issues, relevant research, and district data pertinent to developing a recommendation to the Board of Trustees around facilities, finance and instructional programming. During this process many meetings and many hours were dedicated to developing recommendations.

The instructional subcommittee brought three recommendations:

- 1) Grade configuration of K-6, 7-9 and 10-12
- The configuration/design of the district up until the early/mid 70's

- 2) Grade configuration of k-8 and 9-12
- 3) Giving over high school operation in either configuration to a third party, using a request for proposal process.

At a Study Session on December 16, 2009, the Board of Trustees discussed and came to a consensus to adopt the K-6, 7-9 and 10-12.

Amazingly, during their next Board meeting on Monday January 5, 2009, the Trustees (Robert Bass not included) ignored and rejected the subcommittees recommendations, and their own study session decision, and voted to adopt a configuration that was not considered during the 3 months of meetings and the many hours of dedicated deliberation on this matter.

The configuration adopted by the Trustees by a 6-1 vote was K-6, 7-8 and 9-12. This configuration would include a separate isolated 9th Grade Academy within the High School where 9th graders would be isolated and segregated from the rest of the student body.

It is clear, to this writer, that the decision to keep the 9th Grade Academy in the High School was made by a few individuals operating behind the scenes. It is also clear to me that the individuals making this decision did so prior to and without honest regards for the recommendation made as a result of this rigorous public participation process. The main promoter of this experimental concept came to the January 5th Board meeting with an agenda to dogmatically push this idea until it was adopted by the Board.

Quite frankly, I am outraged and offended when our public servants (school board trustees and other elected officials) ask for public participation from the citizens, and after receiving recommendations these public servants either ignore or water down our thoughtful ideas.

To Trustee Gill Garrett and the other trustees (Dorkins, Northcross, Bradley-Petters, Cain and Cadd) who voted for the K-6, 7-8, 9-12 configuration/design I implore you to reconsider your decision of January 5, and adopt the K-6, 7-9 and 10-12 configuration.

"The configuration or school design K-6, 7-9 and 10-12 should be adopted because it has worked in this community."

Without fear of thoughtful contradiction, I submit to you (Board of Trustees) and the community that the changing of the school configuration/design in the early/mid 70's, along with forced busing, the resulting elimination of neighborhood schools and other related factors (white and professional flight, economic factors including job loss) are directly responsible for our current educational mess. Before these outrageous and disastrous changes were made, the School District of The City of Pontiac was considered one of the best in America.

K-6 Design

Recently, the district made a wise decision to remove six-graders from the middle schools and place them back in the elementary school where they belong. This was a great first step to correct the problem of six graders going to middle schools and getting lost in educational confusion. Research has demonstrated that the placement of six graders in the middle school setting was a complete disaster and caused permanent harm to many in this age group and stunted their future educational and psychological growth. By leaving the six-grader in the elementary school we allow this group to grow and mature to the point where they are physically, psychologically and emotionally mature enough to make the move to the 7-9 middle or Jr. High School configuration.

7-9 Design

Research has also illustrated that 9th grader in the high school setting have a greater drop-out rate, and are also stunted in their educational and

psychological growth. As in the situation with the six grader, 9th graders need to remain in the cocoon of the middle or Jr. high school setting until they have matured physically, psychologically and emotionally. The past 30+ years has demonstrated that this maturation cannot happen in the high school setting, and we have grave doubts that it will happen in the isolated and segregated setting of a separate 9th grade academy.

Solution: Let's Go Back to the Model that worked in The School District of The City of Pontiac! K-6, 7-9 and 10-12!

Finally, let me reflect a few minutes on the past glory days of the Pontiac School District to further illustrate my point.

Did you know that back in the day, the Pontiac school district produced Al Taubman - Developer of many malls across the United States including the first mall in the world Northland Shopping Mall in Oak Park, MI; the world's largest mall in Minneapolis, MN; and Great Lakes Crossing? Did you also know that Dan Murphy (Oakland County's first County Executive), Lynn Allen (long-time Oakland County Clerk) are graduates from the Pontiac School district? How many of you know that the renowned attorney Albert Hatchett and former 50th District Court Judge Christopher Brown are products of the Pontiac School District? Were you aware that Ronnie McNair, now a member of the famed Four Tops and international jazz musicians Hank, Thad and Elvin Jones once walked the halls of Pontiac Central and Pontiac High respectively? Surely you have heard about the achievements of Olympic gold medal winners Miki King and Hayes Jones, both graduates from the school district of the City of Pontiac. Bet you did not know that the 1964 state semi-finalist Pontiac Central basketball team consisted of a future doctor in Gerald Henry, a future mayor in Walter Moore, a future attorney Alvin Keel and a future

school principal in William Morgan. Other high achievers from our school district from back in the day include former TPN Teacher of the year Ruthie Winfield, Rev. Bill Tipton, comedian Terry Hodges, Donnie Soden, Dana Coin, Judge Phyllis McMillen, Judge Preston Thomas, Judge Leo Bowman and attorneys Darryl Mitchell, Joe McMillen, Harrison Munson, Russell Anderson and Kenny Burch. Dr. Gary Weeks, Dr. Bruce Turpin, Dr. Larry Russell, Dr. Jeff Martin, Dr. Beverly Goodman, Dr. Terrance Haynes, Dr. Drew Marshall, Dr. Amos Johnson, Jr. and Dr. Henry Smith are all graduates of the Pontiac School district, under the K-6, 7-9 and 10-12 school configuration/design!

Finally it is important to note that in the late 1950's, early 1960's and 70's the Pontiac School district was considered by many to be one of the top school districts in America! In addition, Pontiac Central High School has been an accredited high school since 1849. It is the oldest high school in Oakland County, Southeastern Michigan, and has the largest alumni of any school in Oakland County.

So, there you have it, the Pontiac school district was once a great place to send your child if you wanted him or her to excel academically, socially and athletically. I conclude my travels down memory lane with this statement "if we did it once; we can do it again".

Let's Get It Right This Time....stop experimenting with our children.

So there you have it; my 2 cents worth. Hopefully these suggestions will be received in the spirit in which they are presented - as a primer or catalyst for correct action!

Again please keep in mind that the suggestions made in this editorial is the opinion of this writer and is shared by many unheard voices in this community. We welcome your comments!

the December meeting in Lansing, Michigan at a recent meeting.

Commissioner Hatchett was first appointed to the Michigan Association of Counties (MAC) Board of Directors in March 2007. She was name board member for Region 5, which includes the counties of Oakland, Wayne, Macomb, Monroe, and Washtenaw. She made history as the first African American woman to hold this position from Oakland County and has once again made history as the first African American woman to be elected to the second vice president position in the 110 year history of the association.

Michigan Legislature Reaches Deal on Expansion of Detroit's Cobo Hall

LANSING - In a move that will jumpstart Michigan's economy and protect thousands of jobs, the Michigan House of Representatives today passed a bipartisan, bicameral plan to expand and modernize Detroit's Cobo Hall. The move will ensure that Michigan remains the home of the North American International Auto Show and cements Cobo Hall as a prime international destination for events from around the world.

"With Michigan's working families struggling to make ends meet, we must make every effort to protect Michigan jobs," said State Representative Virgil Smith (D-Detroit). "This is not a perfect deal, but over 16,000 of our residents rely on Cobo for their livelihoods. We must act now to ensure that this Michigan landmark continues play a vital role in growing our economy and attracting new businesses to the area."

Tens of thousands visit Cobo Hall each year, many to visit the North American International Auto Show, one of Michigan's signature events. In addition to being responsible for over 16,000 jobs, it is estimated that Cobo brings \$600 million in revenue annually to Michigan's economy.

Recently, Nissan and Mitsubishi made waves when they pulled out of the auto show.

They join Suzuki and Porsche, who cited Cobo's limited space and obsolete facilities in making their decision. In fact, preparations for the auto show have to begin six months in advance, in order to adequately deal with the inefficiencies of Cobo's loading docks.

The House-passed plan will transfer ownership of Cobo Hall from the City of Detroit to a new regional authority, made up of a five member board with representatives from the tri-county area. This board will have the initial task of overseeing the renovation and expansion, and later will manage the property under strict rules designed for efficiency and transparency.

Funding for the expansion will come from a redistribution of current revenues. No new taxes will be created and no taxes will be raised to pay for the project.

"Without this expansion, we are in danger of losing thousands of jobs and losing the auto show," Smith said. "The authority that will oversee the renewal of Cobo Hall will come from all over the metro Detroit area with one goal in mind - putting the interests of Michigan families first. Expanding Cobo Hall is a key part of our plan to move Michigan forward by creating good-paying jobs now."

The Need for Monetary Reform

Monetary reform is the critical missing element needed to move humanity back from the brink of nuclear disaster, away from a future dominated by fraud and warfare, toward a world of justice and beauty.

The power to create money is an awesome power - at times stronger than the Executive, Legislative or Judicial powers combined. It's like having a "magic checkbook," where checks can't bounce. When controlled privately it can be used to gain riches, but more importantly it determines the direction of our society by deciding where the money goes - what gets funded and what does not. Will it be used to build and repair vital infrastructure such as Levees to protect major cities? Or will it go into warfare or real estate loans, creating asset price inflation - the real estate bubble.

Thus the money issuing power should never be alienated from democratically elected government and placed ambiguously into private hands as it is in America in the Federal Reserve System today.

Indeed most people would be surprised to learn that the bulk of our money supply is not created by our government, but by private banks when they make loans. Through the Fed's fractional reserve process the system creates purchasing media when banks make loans into checking accounts. So most of our money is issued as interest-bearing debt.

We are borrowing this money system from private banks when instead we should own

the system, not rent it. Our government has the sovereign power to issue money (Art.1, Sect.8) and spend it into circulation to promote the general welfare through the creation and repair of infrastructure, including human infrastructure - health and education - rather than misusing the money system for speculation as banking has historically done. Our lawmakers must now reclaim that power!

Money has value because of skilled people and resources and infrastructure, working together in a supportive social and legal framework. Money is the indispensable lubricant that lets them "run." It is not tangible wealth in itself, but a power to obtain wealth. Money is an abstract social power based in law and whatever government accepts in payment of taxes will be money. Money's value is not created by the private corporations that now control it.

Unhappily, mankind's experience with private money creation has undeniably been a long history of fraud, mismanagement and even villainy.* Banking abuses are pervasive and self-evident. Major companies focus on misusing the money system instead of production. For example, in June 2005, Citibank and Merrill Lynch paid over \$1.2 Billion to Enron pensioners to settle fraud charges.

Private money creation through fractional reserve banking fosters an unprecedented concentration of wealth which destroys the democratic process and ultimately promotes imperialism. Less than 1% of the population

claims ownership of almost 50% of the wealth, but vital infrastructure is ignored. The American Society of Civil Engineers gives a D grade to our infrastructure and estimates that \$1.6 trillion is needed to bring it to acceptable levels.

That fact alone shows the world's dominant money system to be a major failure crying for reform.

Infrastructure repair would provide quality employment throughout the nation. There is a pretense that government must either borrow or tax to get the money for such projects. But it is a well enough known, that the government can directly create the money needed and spend it into circulation for such projects, without inflationary results.

Monetary reform is achieved in 3 parts which must be enacted together for it to work. Any one or any two of them alone won't do it, but could actually further harm the monetary situation.

First, incorporate the Federal Reserve System into the U.S. Treasury where all new money is created by government as money, not interest-bearing debt, and spent into circulation to promote the general welfare; monitored to be neither inflationary nor deflationary.

Second, halt the banks privilege to create money by ending the fractional reserve system in a gentle and elegant way. All the past monetized private credit is converted into U.S. government money. Banks then act as intermediaries accepting savings deposits and loaning them out to borrowers; what

people think they do now.

Third, spend new money into circulation on infrastructure, including education and healthcare needed for a growing society, starting with the \$1.6 trillion that the American Society of Civil Engineers estimate is needed for infrastructure repair; creating good jobs across our nation, re-invigorating local economies and re-funding government at all levels.

The false specter of inflation is usually raised against such suggestions that our government fulfill its responsibility to furnish the nation's money supply. But that is a knee jerk reaction - the result of decades, even centuries of propaganda against government. When one actually examines the monetary record, it becomes clear that government has a superior record issuing and controlling money than the private issuers have.* Inflation is avoided because real material wealth has been created in the process.

This press release from the recent monetary reform conference in Chicago, which I addressed highlights the beneficial effects of the plan both in terms of saving on interest, and in avoiding such disasters in the first place:

Money Reform Plan Would Save Taxpayers \$ Billions Per Year in Katrina Cleanup

"An alteration in the way money is introduced into our economy would save at least \$10 billion dollars per year in the cleanup and

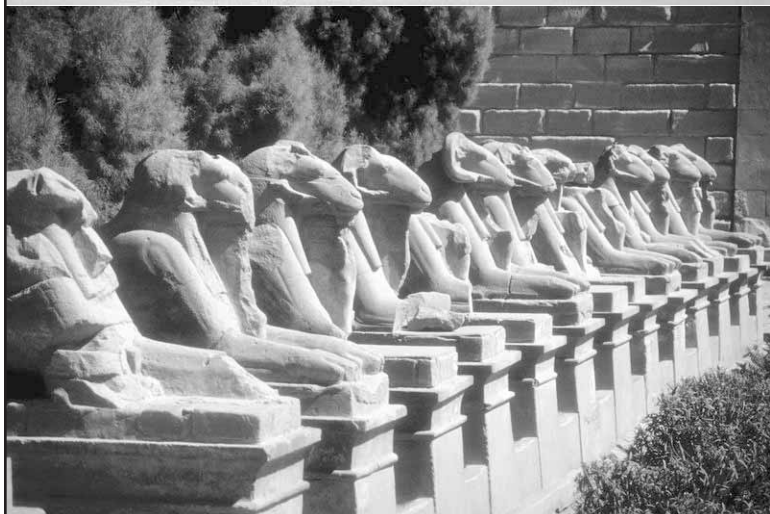

Mills elected President of Ghana, promises to heal wounds

Accra, Jan 8, GNA - Law Professor John Evans Atta Mills was on Wednesday sworn in as the sixth president of Ghana and the third under the Fourth Republic, promising to heal to nation's wounds and ensure national unity. Swearing on the Bible, he took and subscribed to the Oath of Allegiance and the Presidential Oath, administered by the Chief Justice, Mrs Justice Georgina Theodora Wood.

The inauguration took place before a milling crowd of Ghanaians, including outgoing President John Agyekum Kufour,

and former President Jerry Rawlings, under whom he served as Vice President between 1996 and 2000, as well as some leaders who contested the last presidential elections. Also among those who were present were Nana Addo Dankwa Akufo-Addo of the New Patriotic Party, Dr Papa Kwesi Nduom of the Convention People's Party and Dr Edward Nasigre Mahama of the People's National Convention (PNC), members of the Diplomatic Corps and Members of Parliament.

"I will be president for all Ghanaians, whether they voted for me or not. I'll heal wounds and strive to ensure unity. No Ghanaian should live in fear of armed robbery," he said. "Improvement in internal security would be top on my priorities," President Mills said in his inaugural speech at the Independence Square in Accra.

President Mills, who arrived at the grounds with his wife Naadu at 1418 hours, sporting rich kente cloth in red, yellow and green colours, on white jumper, with brownish yellow ahenema sandals to match, exchanged greetings with dignitaries on the presidential dais where presidents and representatives from West Africa sat.

After the big fontomfrom drums had heralded the taking of the oath, he was

offered the state sword, which endorsed his mantle to lead the over 22 million Ghanaians for the next four years. This was followed by a 21-gun salute in honour of the President who also promised to build a better Ghana on the four pillars of job creation, investing in people, expansion in infrastructure and open and honest government.

President Mills praised out-going President Kufuor for his rich and valuable experience. He observed that the just-ended elections, which he won, were close to a tie, but the sovereign will of the people finally prevailed.

President Mills congratulated Nana Akufo-Addo on his fighting spirit, and, with a blink into memory lane, said the NPP candidate had been a tougher midfielder when they both played football in their days in the University of Ghana, Legon. The President also congratulated the other contestants in the presidential race and harped on his message of change, but said the change was not just for the sake of change, but change in a new

direction "so that we can move forward." He reiterated his message on consensus building and pledged further to ensure audience to the citizenry without room for political vendetta, but respect for the principles of accountability.

President Mills assured Ghanaians of fairness and equity for all, and urged the judiciary, security agencies, and public servants to be loyal and committed to the larger interest of the nation. He assured the business community that "our goal is to create a business atmosphere where local business would go hand in hand with the foreign," and avoid suffering of local business at the expense of cheap imports.

On his foreign policy, Prof Mills said the Government would collaborate with the African Union to help find solutions to the conflicts on the continent, and collaborate with the United Nations to ensure that there was a better and safer place. Echoing the "Gambaga to Accra" slogan of his alma mater, Achimota School, Prof Mills said: "From Gambaga to Accra, let's respond to the call to get mother Ghana on her feet. With strength of character, determination and with the blessing of God, we shall succeed... God uphold Ghana and make our country even greater and stronger."

President Mills confers with foreign delegations

Accra - Jan. 8, GNA - President John Evans Atta Mills on Thursday conferred with a number of foreign delegations at the Accra International Conference Centre (AICC). They included those from Japan, Libya, Kingdom of Morocco and the Federal Republic of Nigeria.

The delegations conveyed separate messages of congratulations to President Mills from their governments and re-affirmed their countries' commitment towards closer cooperation with Ghana. Former Japanese Prime Minister Juichiro

Koizumi led the delegation from Japan and that of Libya was headed by Dr Said Hafiyana, Special

Envoy of Libyan Leader Muammar Gaddafi, while Mr Mohammed Elyazjhi, a Minister of State in Morocco and Dr Bola Almed Tinubu, Former Governor of Lagos State, led the Moroccan and Nigerian delegations, respectively. Speaking to journalists, Dr Tinubu acknowledged the maturity of Ghana's democracy, saying the country had shown leadership and added, "Ghana has made Africa proud".

Architectural students from the School of Architecture of Clemson University to help implement Project Okurase

Accra, Jan. 8, GNA - A two-member student delegation from the School of Architecture of the Clemson University, Charleston in the USA, have arrived in the country to help in designing and constructing the Project Okurase in the West Akyem District of the Eastern Region.

The project involves the building of Nkabom Centre with 16 structures on the site at Okurase for training for job creation, formal education for children and foster families for orphaned children as well as a base for single mothers to acquire basic skills in various vocational training. The project is a joint venture of Nkabom Artists and Craftspeople, a local non-governmental Organisation (NGO) in Ghana, Gethsemani Circle of Friends, a non-profit organisation from South Carolina and the Family Services Research Centre of the Medical University of South Carolina, USA. A number of the local people have been engaged to undertake brick laying training and manufacturing of the needed building materials for the project.

The students, Lindsey Waters and Kyle Keaffable told the Ghana News Agency on their arrival in Accra that they were on a 10-day trip to the country to complement the local initiative of the people of Okurase to develop suitable architectural design for the Okurase Centre in which natural materials and sustainable local architecture would be used. Miss Lindsey said they hoped to look at various different types of building materials at the site of the project so as to design appropriate materials for suitable housing for the target groupings. She said they also intended to adopt a design that would be suitable for the chiefs and people of Okurase.

Miss Lindsey said on their return to the USA, they would hold sessions with other students of the Clemson Architecture Centre-Charleston to come out with an elaborate design for the Centre.

Mr Keaffable said they had so far held discussions with a number of local architects on Ghanaian building technologies and intended to combine such experiences with theirs to come out with a suitable workmanship.

Dr. Cynthia Cupit Swenson of the Medical University of South Carolina, a co-Director of the Project Okurase, commended organisations that assisted in the successful take-off of the project, particularly the "Link with USA for Africa", for donating 1,000 dollars for the project.

Mr. Samuel Nkrumah Yeboah of the Nkabom Artists and a co-Director of the project, in collaboration with the Nkabom Dance Ensemble in the UK, organised music, dance and drum language workshops and held a forum for school children in Los Angeles to create awareness about the project. He also teamed up with Kobina Boni to launch a film entitled 'Madagascar Escape to Africa II', and performed music and dance shows with the employees of the Dream Works Studio in Los Angeles and at the California State University, Los Angeles to share experience as a way of bridging the gap between the cultures of Ghana and America.

Mr Yeboah thanked the North Devon Respect Festival for donating towards the project as well as other organisations and individuals who in diverse ways supported it.

New Oil found in Ghana

UK-based oil explorer Tullow Oil and U.S. producer Anadarko Petroleum made new discoveries around their Jubilee field in Ghana, Tullow said on Thursday.

Tullow Oil said its Mahogany-3 well had made a new discovery beneath its Jubilee field and that the drilling also showed the field extended far further to the southeast than it thought.

The company said in a statement on Thursday that the results raised its expectations for the field, although it did not specify new reserves estimates.

8 New Ways to Keep Your Brain Fit

An intriguing report on trends in brain fitness, by SharpBrains, a market research company focused on applications of brain research, predicted more brain-health offerings in senior living communities and health clubs, development of programs that combine physical and mental fitness into one workout and broad-based government initiatives along the lines of JFK's emphasis on physical fitness in the early 1960s. Just as exercise was the rage in previous decades, today's boomers are embracing strategies to boost memory, sharpen concentration and fine-tune the brain's ability to process information.

Cynthia R. Green, PhD, an assistant clinical professor at Mount Sinai School of Medicine and president of Memory Arts, LLC, a provider of science-based brain fitness training to individuals, corporations and organizations, suggests for those of us who want to incorporate mental training into our wellness routines, that it's an excellent idea to make a daily effort to remain intellectually engaged, which will help enhance your cognitive abilities as you age. Dr Green specifically suggests...

BUILD UP A COGNITIVE RESERVE

Research demonstrates that an active brain is associated with better cognitive health and a reduced risk of dementia, including Alzheimer's disease. Researchers found that participants who spent time on activities such as reading newspapers, playing puzzle games, or listening to the radio frequently were 47% less likely to develop AD than those who did them less

often. It's possible that these activities protect the brain by establishing a "cognitive reserve," helping it become more adaptable and flexible in some areas to compensate for declines in others.

DO DIFFICULT THINGS

Evidence shows that mental stimulation also enhances the brain's networks of connections and encourages "brain plasticity" (the brain's ability to physically and functionally change). Cross-train your brain by doing things you haven't done before, perhaps learning a new language or to play a new musical instrument. To stay sharp, Dr. Green advises that you continually find new projects and hobbies to challenge your intellectual skills. Take a class at the local community college or take a free course online -- universities that offer online courses at no charge include Berkeley University of California (<http://webcast.berkeley.edu/courses.php>)... Carnegie Mellon University (<http://www.cmu.edu/oli/>)... Massachusetts Institute of Technology (<http://ocw.mit.edu/OcwWeb/web/home/home/index.htm>)... and Tufts University (<http://ocw.tufts.edu/>).

PLAY BRAIN-TRAINING GAMES

There are many ways, both offline and online, to engage in fun, daily mental workouts that are efficient and effective:

and other puzzles.

- Memorize a new word and definition each day at www.wordsmith.org.

- Play strategic games such as Battleship and Scrabble (<http://www.puzzlexpress.com/Java/Battle/Battle.htm> and www.download-free-games.com).

- Watch game shows... and participate. Programs like Wheel of Fortune and The Price is Right can not only entertain, but also exercise your brain as well. Check your local television listings for scheduling information. Or go online at wheeloffortune.com or pricesright.com to play.

CHANGE IT UP

If you're right-handed, try doing things left-handed, and vice versa. For example, make phone calls using your less dominant hand. Break up your usual routine -- for instance, changing the order of your morning activities or figuring out as many different driving routes to work as you can.

PLAN ENRICHMENT ACTIVITIES

Listen to music -- especially classical music. The so-called "Mozart Effect" enhances learning. In one small study, college students showed improvements in spatial-temporal intelligence (the ability to mentally manipulate objects in three-dimensional space) after listening to about 10 minutes of a Mozart sonata. You can also

engage your brain by visiting museums and looking at different kinds of art. Attend speeches and lectures on topics of interest -- or on subjects you know nothing whatsoever about. It's never too late to enrich your life culturally and academically, and learning is exercise for the brain.

BEAT THE CLOCK

Not your biological clock -- an actual clock. Dr. Green recommends timed activities, which force you to pay attention, work quickly and flexibly, and look at information in different ways. Time yourself and try to speed up activities to meet challenges you set... putting away groceries or folding laundry, for instance. You can also play timed games such as chess or Boggle with family or friends -- or on your own online (www.fun-with-words.com/boggle.html). At <http://www.nytimes.com/pages/crosswords/>, for \$6.95/month or \$39.95/year, you can purchase access to "Premium Crosswords," which allows you to time yourself, collaborate with other players in real time and have access to exclusive puzzles (free to New York Times subscribers).

LOG ON

There are also software products and computer games that may improve attention, information processing and memory, with evidence suggesting that they are quite useful. In the Advanced Cognitive Training for Independent and Vital Elderly (ACTIVE) trial, healthy adults 65 and over received 10

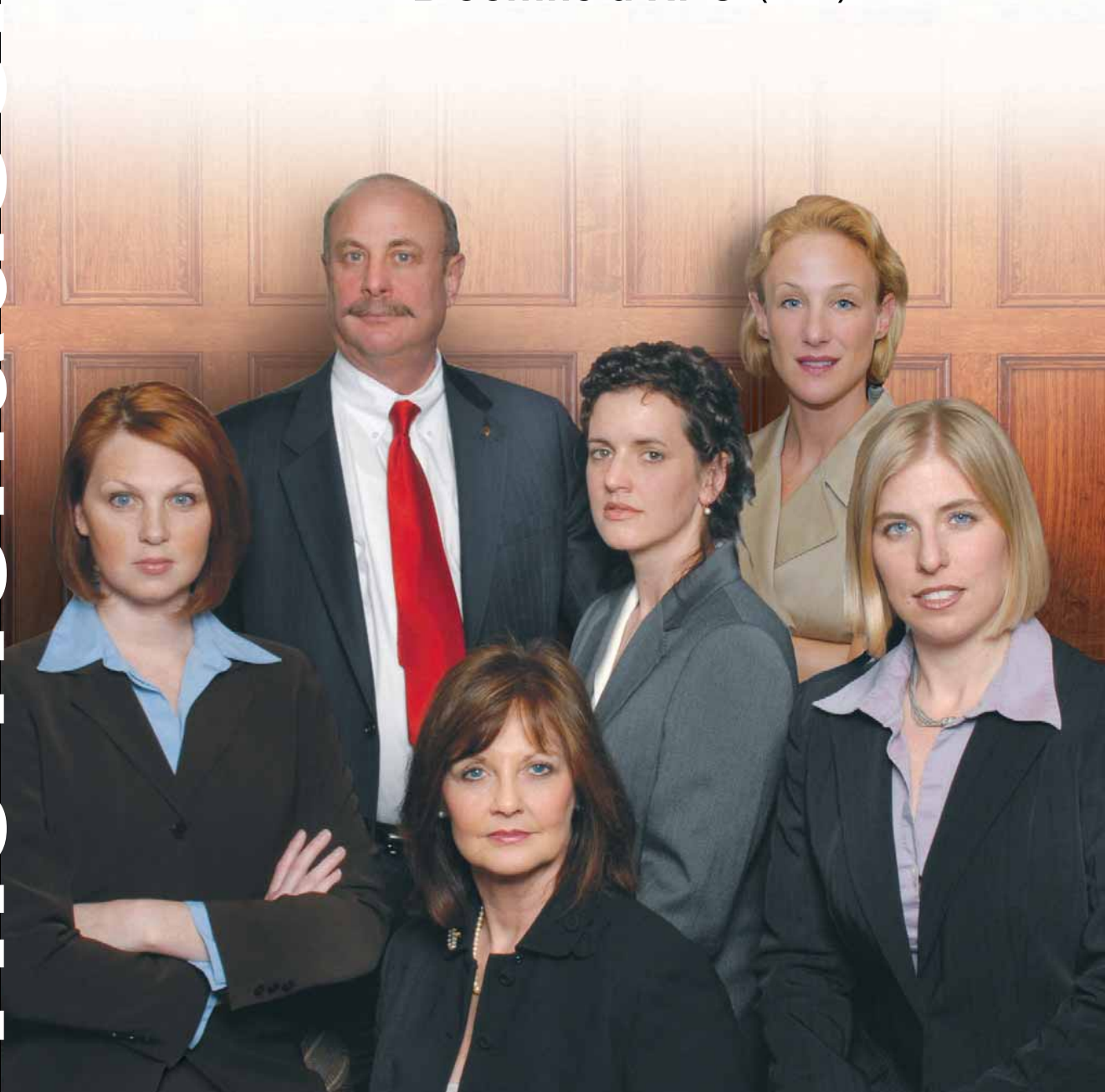

Non-Profit Launches Conflict Resolution Arts Programming for Youth

(Pontiac, Michigan)- On December 18, 2008, dot the i productions, a 501c(3) charitable arts organization, launched Handling Conflicts, a pilot behavior intervention through the arts at the Pontiac Arts & Technology Academy. The 50 minute program began with youth sitting in a circular seating arrangement within arms reach of their classmate because we wanted to make the program comfortable and intimate. As a portion of selected songs from an array of music genres were played, students were asked to discuss the way each song made them feel. Music varied from R&B, Hip-Hop, Dance, Pop, Oldies but Goodies, Disney, Rap, Jazz, Easy Listening, Inspirational, and more. Students were given the freedom to dance as a means for creative expression and many simply rocked in their seats as they felt moved. An open Q & A discussion about aggressive behavior remained continuous throughout the program so that students would get a feel for the importance of controlling angry emotions

and violent acts towards others, especially teachers and peers both on and off of school grounds.

The program was developed for youth, grades 6-12, because of the high requests from students and teachers to reduce the number of violent incidents caused by angry youth during class hours. Today, many Pontiac schools have gone to the extremes of being under Police Surveillance the entire school day and are seeking other alternatives to help keep schools safe. Handling Conflicts is just another way of relieving this need. And now that the program is in demand by students and teachers, dot the i productions is soliciting funding from larger organizations to allow youth from urban schools in Oakland and Wayne counties the opportunity to experience the program. 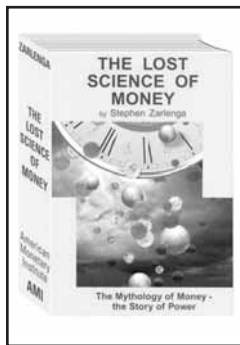

The Lost Science of Money

By Stephen A. Zarlenga



- Traces the money power through three and a half millennia from barter to the Euro.

About the Author: Stephen Zarlenga draws on 35 years of experience in the world of finance, securities, insurance, mutual funds, real estate, and futures trading. He has published 20 books on money, banking, politics and philosophy (including *The Anglo American Establishment*, by Prof. Carrol Quigley). While in his mid 20s he incorporated the Athenian branch of an English life insurance company, earlier opening several European markets for the parent firm, IOS.

A few years later he built the U.S. distribution network of the then leading American mutual fund concentrating in gold shares. As a member of the New York Futures Exchange (a subsidiary of the New York Stock Exchange) he specialized in trading the complex CRB futures index for several years. Thus the author is more than familiar with both the practical and theoretical sides of our market economy.

Yet he calls into question and challenges the basis, and Achilles' heel, of American Capitalism: the private control and resulting misdirection of the nation's monetary system.

Stephen Zarlenga holds a degree in Psychology from the University of Chicago (and has done postgraduate work at NYU), where he was in the final graduating class under the revered Hutchins' curriculum which focused on critical reading and thought. This training, combined with his work experience, and years of research, enabled him to re-formulate the Lost Science of Money.

The author began focused research on the money problem in 1991, eventually drawing on over 800 monetary source books and materials to formulate this thesis. In 1996, he helped establish the American Monetary Institute to further the research. In 1999, Conzett Verlag of Zurich, Switzerland translated and published the work in German. This expanded English version released in 2002, establishes the author as a leading voice in the field of monetary history, theory and reform.

sessions of memory training, reasoning training or speed of processing training. The sessions not only improved their mental skills in the area in which they were trained, the improvements lasted for at least five years.

Dr. Green recommends that you choose a game that increases the level of difficulty as your skills improve, much as a personal trainer does with athletic training. Programs include games, such as Brain Age from Nintendo (www.brainage.com), and computer software such as Fit Brains (www.fitbrains.com) and Lumosity (www.lumosity.com). At <http://games.lumosity.com/chimp.html>, for example, you can play a free sample game -- "Are you smarter than a chimp?" This pits your memory against that of Ayumu, a seven-year-old chimp who has already

beaten college students at Kyoto University.

USE IT OR LOSE IT

The bottom line is that there are many strategies that you can undertake to keep your brain active and enhance cognitive fitness. The key is to stay stimulated: Use it or lose it. Read more about Dr. Green's brain fitness tips on her blog, www.prevention.com/staysharp.

rebuilding aftermath of Hurricanes Katrina and Rita. If the clean-up loans last the normal 30 years, the savings will be over \$250 billion," says Stephen Zarlenga, Director of the Institute. The plan, known as The American Monetary Act was discussed at the American Monetary Institute 2005 Monetary Reform Conference....

The proposed three part reform of our currency system would have the U.S. Government directly spend the money into circulation rather than the present method of allowing the banking system to create the money and then the government borrowing the money. Funding such infrastructure expenses through bonds generally doubles to triples their final cost.

The reform avoids this expense by removing the fractional reserve provision of the present system, which in effect allows the banking system to create the much needed new money that must be continually introduced into the economy, as population and economic activity expands; or when emergencies such as Katrina, or warfare require great expenditures. Under the reform only the U.S. government, not the private banking system would be allowed to create money.

"What we're proposing is very similar to the 'Chicago Plan' which came out of University of Chicago economists in the 1930's and was widely supported nationwide by the economics profession back then," said Zarlenga.

Under the plan the government spends the new money into circulation on necessary infrastructure, including education. A presentation at the conference by the American Society of Civil Engineers pointed out the deteriorating condition of American infrastructure, which currently receives an overall grade of D, and is predicted to reach D- soon.

Most of Katrina's Damage on New Orleans Was Avoidable

"This method of introducing new money through infrastructure creation and repair would actually have stopped most of the

damage and loss of life in New Orleans because the money would have been available to repair the levees, and they would have probably held" said Zarlenga.

"Under the present private control, money goes largely into speculative bubbles, including Wall Street games and real estate" he said, "Under societal control it would go much more to promoting the general welfare. Inflation is avoided because real material wealth has been created in the process, and catastrophic loss including loss of life is prevented." - End of press release.

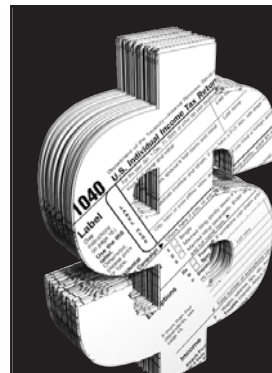
Lawmakers have often believed they could ignore the big questions on how our money system is structured. Right from the Constitutional Convention delegates ignored societies monetary power and the excellent record of government issued money in building colonial infrastructure and giving us a nation.* They left the money power up for grabs when properly estimating it would have meant placing it in a fourth, monetary branch of government. History shows that the money power will be a fourth branch whether we recognize it as such or not. It's not safe to leave so much power and privilege in private hands! It's counter to our system of checks and balances. The developing crisis requires us to re-evaluate and focus on it now. That's my suggestion. Lets fulfill our responsibility to get a real understanding of this problem and the solution.

As the late Congressman Wright Patman, Chairman of the House Committee on Banking and Currency for over 16 years, said, "I have never yet had anyone who could, through the use of logic and reason, justify the Federal Government borrowing the use of its own money....I believe the time will come when people will demand that this be changed. I believe the time will come in this country when they will actually blame you and me and everyone else connected with the Congress for sitting idly by and permitting such an idiotic system to continue."

NEW NO FAULT PROBLEMS

Most consumers in the State of Michigan are aware that we are a No Fault State. "No Fault" refers to certain aspects of our automobile insurance. The original statute was introduced in 1973. At that time, the basics of the statute were: a person could not

recover for pain, suffering and emotional distress if injuries did not reach a certain threshold. The threshold at the beginning of the application of the statute was: serious, permanent disfigurement and/or serious impairment of necessary body functions. The statute did not define either of those standards with any specificity. Nor were there definitions elsewhere in the statute.

From the beginning, this became problematic. The legislature attempted to solve this problem by adding requirements as opposed to adding definitions. Sometime later, 10 or 15 years after the original statute started, the first two requirements continued plus the injury had to be "objectively manifested". Again, this is not a well defined set of terms. It was easy when one could see a broken bone on an x-ray. It was less easy when a physician could see spasms upon palpating a muscle group. After all, a physician's observations were also objective. The insurance carriers weren't happy about this and put pressure on the legislature and the

courts.

Over the years, the situation evolved. In the early 1990s the standard was yet again circumscribed, this time to include the first two items, e.g. serious, permanent disfigurement and/or serious impairment of necessary body function; the second item: objectively manifested, and a new item: significantly impacting the activities of daily life.

Each of those items became the subject of interpretation in the higher courts of this State.

In 2004, certain members of the Supreme Court of the State of Michigan decided to take it into their own hands to expand the requirement (that is to say, to make it more difficult to recover damages for pain, suffering and emotional distress) by adding yet another level of difficulty. The legislature didn't add this level of difficulty. The Supreme Court added this level of difficulty. The Supreme Court decided that all of the preceding items mentioned in this article had to apply plus the injuries had to "significantly impact the trajectory of a person's life". This is often referred to as "the Kreiner standard".

Many people (including the writer of this article) feel that this standard is wrong. It leads to foolish results. In one of the original cases, a carpenter injured the tendons in one hand. He was hospitalized for days. He had surgery. He was off work for three months. The Supreme Court opined that this was insufficient interference with the trajectory of this person's life. Heaven only knows what that meant to this person's life in the

long run. Then, in another case, one of the appellate authorities ruled that an elderly person who was blind and who had had a minor injury but could no longer knit due to her injuries could collect because the trajectory of her life was, indeed, affected. A young carpenter supporting a family could face financial ruin as a result of months off work and he would be barred from recovery. An elderly person who could not knit for entertainment could recover.

Now the Supreme Court is about to change. There are three justices who have supported Kreiner: Justices Markman, Young and Corrigan. There are three justices

who have questioned Kreiner: Justices Cavanaugh, Kelly and Weaver. Justice Taylor, who authored the Kreiner decision is no longer on the Supreme Court, having been rejected by the voters of the State of Michigan. Shortly we will have a new justice: Diane Hathaway. Many believe that the new makeup of the Court will warrant a re-visit to the Kreiner decision. Many hope that this judge-made law will be revoked.
