Turnaround Plan Targets Failing Schools

National expert testifies in support of proposed school turnaround plan

LANSING - The House Education Committee recently held a special hearing to discuss a turnaround plan introduced by State Representative Tim Melton (D-Pontiac) that will improve Michigan's failing schools by creating new standards and restructuring options. A national expert on school recovery plans testified at the hearing.

"By not having a game plan to turnaround our failing schools, we are damaging our children's ability to reach their full potential," said Melton, Chair of the House Education Committee. "These same kids that make up the next generation of our communities need strong schools to succeed in a world growing more competitive every day. The status quo is not working in our schools and we all have an obligation to our children that goes beyond mere cosmetic changes."

Last month, Melton introduced a plan to help students in failing school districts. The

legislation creates a Reform Officer to design and implement a turnaround plan for failing schools. The Reform Officer will be solely responsible for the review and implementation of a restructuring strategy for a school placed under his or her control, and has the power to assume direct operation of a school. The Reform Officer has the authority to evaluate staff and implement new building policies. The plan also allows for a high-performance charter school to locate within five miles of a school that is considered a failure.

Paul Vallas, current superintendent of the

Recovery School District of New Orleans, was on hand to give testimony at a recent hearing. Vallas, who turned around the Chicago and Philadelphia public school districts, spoke in support of Melton's reform plan.

"Our children deserve better from our state, from our schools, from us," said State Representative Bert Johnson (D-Detroit). "Our state can't afford to continue short-changing our children by sending them to subpar schools. I urge my colleagues to quickly pass this plan to give our children every chance to succeed."

An Open Letter To the Pontiac Board of Education Trustees

Over the past 35+ years this writer has spent countless hours researching, planning, developing and implementing programs and activities to help resolve the many problems facing young people in the City of Pontiac and other urban communities across America. During this time period I have come to the realization that the single biggest negative impact on the development of our children is the mis-education that they receive in our public schools, not only in Pontiac, but across this potentially great nation of ours, particularly in urban communities.

To counter this mis-education that is prevalent in our public schools we (The Youth Development Institute, New Pontiac, Inc., The Pontiac News and The Campy Russell Community Foundation) have developed the Urban School District Improvement Project (USDIP) a comprehensive five component strategy to help mitigate (solve) this most critical problem. Aspects of this program has been

used by our various organizations over the past 35+ years to assist hundreds of young men and women in their quest to become productive citizens, in spite of the mis-education that they have received in our school system.

Over the past 2 years we have made presentations to the board and/or board members and have had several meetings with members or representatives of the school administration during which we have offered our assistance and support in addressing the grave and severe problems of lack of student achievement, parental involvement and educators inability to properly motivate, stimulate, educate and cultivate our children. We have also conducted a community survey and garnered community support for this effort by getting hundreds of concerned citizens to sign petitions requesting that you give serious consideration to our proposals.

The reaction that we have received from our elected board members has not been appropriate; in fact, it has been unbelievably crude, nasty and inappropriate. We have been asked to leave public meetings, ignored, lied on, investigated, and accused of trying to bully the board.

Ladies and gentleman of our elected Board of Education.... We are not the enemy! The enemy is the lack of student achievement, lack

of parental involvement and teacher disconnect. The enemy is the ongoing mis-education of our children, and the continuation of a system that has fallen to the level of being a feeder program for the penal and welfare system. The enemy is the individuals who come into this community and cause you to turn on your neighbors, family, friends and customers.

As I stated during my presentation before the board back in May, I am a friend and supporter of this district who simply want to provide help where help is clearly needed! On behalf of the community including my five grandchildren and hundreds of relatives, friends and concerned citizens, I ask that you direct your paid administrators to give serious consideration to our proposals. What we are proposing is not being done in the district and is very much needed right now!

Yes, the cost of this proposal is around 1 million dollars, which on the surface appears to be a large sum of money. However, as you know based on our detailed cost breakdown, the real price is under \$225 dollars per family, based on 4,000 families being served by this most important program. As you are also aware our request is for Title I (At-Risk) funds that will go back to the funding source if not spent timely! (Last year between 2 and 3 million of these funds were not spent timely, in fact over the past several years over 10 million of these Title I dollars have had to be reallocated) Also for the record this price is a drop in the bucket when you consider that you receive between \$8,000 to \$10,000 dollars per student from the various funding sources. In spite of what you have been told and/or believe, they do not know how to address the serious problems that this district is facing, we need to work together to solve this grave crisis. We believe

that our USDIP initiative (if properly implemented) provides solutions to a very manageable problem. We have listed on this page the outline of this project for you and the community to review. Again!

Summary of Program Components

A Comprehensive 5 Component Approach

1. Parent Education, Training & Involvement (PETI). To actively involve parents in the academic and social development of their children by providing the training to the parents that is needed to assist the parent to become more effective in preparing their child to succeed in school, friendships and in athletics. Provide necessary training to the parents that is designed to facilitate cooperation with and support of the school district administration and staff. The Parent Success Kit and Workshops along with other activities are utilized to accomplish goals of this aspect of project.

2. Student Academic Excellence

Initiative (SAEI). To improve the academic achievement and social skills of specific At Risk and other students who are in need of academic and social support and training. The USDIP utilizes The Student Success Kit and Workshops along with the SYP & SC and other activities to achieve project goals.

3. Educators Training Professional Development -At Risk Conference . Mandatory District-wide training Conference for teachers administrators, and other instructional staff "How To Stimulate, Motivate, Educate and Cultivate - a Valuable Untapped Resource - The Young Black Male and Female and Other At-Risk Students"©. This District wide staff training initiative is designed to provide administrators, teachers, parents and other instructional staff with the knowledge needed to teach and train the students within the urban school district. This unique, timely and critical event will also serve as a forum where educators and others can devise additional methods to solve the problems encountered by this segment of the population.

4. Summer Youth Program & Sports Clinic (SYPSC). SYPSC is an 8-week summer youth program and sports clinic that is designed to compliment the PETI/SAEI by imparting instruction regarding sports and leisure participation to improve personal discipline, concentration, motor skills/coordination, academic skills, and organizational behavior in the minds of students who participate in interscholastic activities (Sports).

5. Positive School & Community Public Relations and Marketing YDI in conjunction with our community newspaper The Pontiac News, proposes to implement a comprehensive community relations and marketing program that will identify, highlight and actively publicize and report positive programs to the community that support high student achievement, parental involvement training/education and other community collaborations that will foster the renewal of the Urban School District.

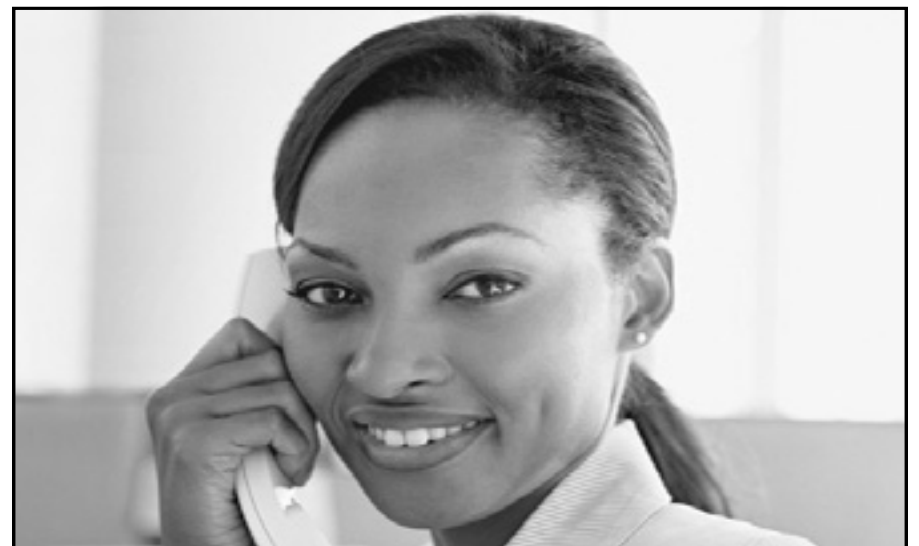

Pontiac School Board Trustees Approve Voter Recommendations for New High School

PONTIAC HIGH SCHOOL THE OLD, NEW NAME FOR THE NEW HIGH SCHOOL

On April 14, 2009 Pontiac School District Board of Trustees approved an old name for the new name of the new high school to open in the fall. The Board voted 7-0 in favor of naming the new high school Pontiac High School which was the original name of the only high school in the city prior to the addition of Pontiac Northern High School. Recommendations were submitted following the student and community voting on the new name, colors and mascot. Pontiac Trustees also approved the colors and mascot that won the most votes from students and community members. The new colors are Purple, Black and Silver and the new mascot is the Phoenix.

Nearly 3,000 ballots were cast during the period of March 31st through April 8th at various venues from online to City Hall, Pontiac Library, Board Office and the three middle schools and two high schools. The other choices for names were North Central and Obama High Schools. Other choices for colors were Red, Orange, White and Blue, White, Silver while the mascots were Warriors and Panthers.

The new high school will open in September 2009 and will have four academies which include a Business, Finance and Entrepreneurial Academy, Arts and Communications Academy, Scholars Academy and a Ninth Grade Academy. Many alliances and partnerships are being refined and formed to ensure exciting, efficient curricular offerings that give students a global competitive edge which they need in today's world.

Several activities and events are being planned throughout the school year into the summer to encourage a smooth, efficient and unified transition. The students are definitely

hopeful and optimistic as they forge ahead to assist in the district's future hold and understand being positive minded to work towards positive results.

More Background:

The district is facing a \$10+million budget deficit due to various reasons which include declining enrollment and state funding. At present, there is a near 20,000 seat capacity with an enrollment of approximately 7,200 students not including preschoolers. The conclusion was that 50% of the buildings (8-9 buildings) including one high school must be closed and buildings reconfigured to create the best learning environment possible for students. The redesign of the district includes keeping the pre-school, special needs and alternative education programs. The buildings remaining open are as follows: P.E.A.C.E. Academy at Frost (Pre-school), Kennedy Center (Special Needs), Jefferson Middle School (which will become kindergarten through 6th grade), Alcott Elementary (K-6), Herrington Elementary (K-6), Owen Elementary (K-6), Rogers Elementary (K-6), Whitman Elementary (K-6), Whitmer Human Resource Center (WHRC) (Pre-K-6), Madison Middle School (grades 7 - 8) and Pontiac Northern High School which will become Pontiac High School.

The Advisory Committee, after several months of research and meetings since October 2008, submitted a plan with three options that would reconfigure grade levels as well as close some buildings. The Board of Trustees voted on Monday, January 26, 2009 to close the following schools: Crofoot, Emerson, Franklin, LeBaron, Longfellow Elementary Schools, Lincoln Middle School, Bethune and Pontiac Central High School.

Every student in Pontiac will soon have the opportunity to attend a completely reinvented secondary program when the doors to the new high school open in September 2009. Sale of the Silverdome

A big question throughout S.E. Michigan is "what is going on with the Silverdome?"

As you may know, the Silverdome is being offered for sale by CB Richard Ellis. The city is actually in the process of extending a final offer of sale to the current bidders. If we are unable to come to a close, then we will begin a new and different strategy for selling the property.

Movie Studio

Plans to locate a motion picture and television production studio (with up to 3,600 jobs once the facility reaches capacity) are moving forward. The City and the developer, Motown Motion Pictures, have come to an agreement regarding a tax-free renaissance zone and the necessary paperwork has been sent to the State of Michigan for approval. The State actually approved the renaissance zone yesterday. All parties worked together to move this matter through the city in as quick and efficient a manner as possible. Motown chose Pontiac over many other cities in Michigan and the rest of the country because Pontiac is a great place to do busi-

ness.

Some people have asked why the city would give any tax incentives when times are so tough? The answer is that we believe the investment and jobs that will be generated at other sites coupled with the income tax revenue from the new Motown workers will more than cover the amount of tax capture that will be forgone by the City. Pontiac is an excellent investment opportunity and this project could help to put Pontiac at the heart of a new industry in Michigan.

Another question is why did the Mayor, Emergency Financial Manager and City Council sign-off on the renaissance zone? The answer is that all parties worked together quickly and cooperatively to analyze and approve the renaissance zone and we wanted to ensure that there would be no problems down the road with the Michigan Economic Development Corporation (MEDC) or other approval authorities because we are working in a new streamlined process.

Number of Police

You may have heard the city will soon be getting new police officers. While we are hopeful, this is not a guarantee. Chief Valard Gross and the Executive Office have applied for a competitive federal grant that will allow the City to bring back more officers. With thousands of communities across the country in positions similar to Pontiac, we are expecting strong competition. Award decisions will be announced in late August of 2009.

As we await the grant award decision, we are still working with the assistance of the Oakland County Sheriff and State Police to provide the highest level of service possible.

Televising City Council Meetings

A number of weeks ago, the EFM requested that City Council meetings not be aired any longer on cable TV in Pontiac. This was because he felt that these meetings had become an opportunity for grandstanding and spreading negativism by a few members of the community. He believed that Pontiac's morale needed to be raised rather than be brought down by a few outspoken individuals.

Since then, a number of people have said that they would like to continue to see these meetings on television because it is difficult for them to actually attend the meeting. Others have said that the EFM should not be censoring the flow of information in the city. Still others have said that they think the City Council meetings have been running more efficiently since they have not been televised.

The EFM now has decided to resume the televising of City Council meetings as soon as possible.

Statement about General Motors Bankruptcy Filing

Pontiac, Michigan, June 1, 2009 -- The following is a statement made today by Oakland County Executive L. Brooks Patterson about General Motors filing for reorganization under Chapter 11 of the federal bankruptcy code:

"This is a sad day for the Motor City and our domestic automobile industry," Patterson said. "The iconic General

Motors has been brought to its knees. Oakland County has pledged to work with GM and its successor company to turn its fortunes around. Further, we are putting the resources of our office to work in an effort to spare loyal GM employees and those of affected suppliers from any further pain, as much as possible. We hope this is a brief stint in court and that GM will soon be manufacturing quality cars again."

Melton: 90-Day Foreclosure Lifeline Agreement Reached

Plan to help homeowners, awaits action in the Senate

LANSING - In a move that will aid struggling homeowners trying to hold on to their piece of the American Dream, State Representative Tim Melton (D-Pontiac) voted for a compromise plan reached with Senate leaders that will extend a 90-day lifeline to residents at risk of foreclosure who seek help. The plan, originally proposed by House Democrats in February, awaits action in the Senate.

"In these tough economic times, it is important to have a Legislature that stands up for our citizens," Melton said. "Thousands of families across Michigan have lost their homes because of situations out of their control. It is important to me that the residents of Pontiac and Auburn Hills - and all Michigan residents - have the opportunity to work with their lenders in order to keep their homes."

After weeks of negotiations between the House and Senate, the two chambers came to an agreement that will allow the House

Democrats' plan to be sent to the Governor. The plan will create a 90-day lifeline for homeowners at risk of losing their home who commit to working with their lender and a housing counselor. Counselors are available through the Michigan State Housing Development Authority (MSHDA) and the U.S. Department of Housing and Urban Development (HUD).

According to RealtyTrac, Michigan ranked sixth in the nation in foreclosures in the first quarter of 2009, with more than 33,000 properties in foreclosure. In 2008, more than 145,000 Michigan properties statewide were in foreclosure - a 21 percent increase from 2007 and a 108 percent increase from 2006. In the first four months of 2009, Oakland County saw 6,919 homes fall into foreclosure.

"Because of the foreclosure epidemic, the very fabric of our neighborhoods and communities is beginning to unravel," Melton said. "Keeping our families in their homes will help get us through these tough economic times. I applaud my colleagues for coming together for our families and passing this very important plan."

Congressman Peters Statement On The Future Of General Motors

Troy, MI - Congressman Gary Peters, whose Michigan congressional district is home to three GM plants scheduled to cease production, Chrysler World Headquarters and more auto suppliers than any district in the country, issued the following statement today following GM's bankruptcy filing and reports of planned plant closures:

"I am hopeful that General Motors can emerge from bankruptcy quickly as a stronger and more competitive company. A shorter proceeding is possible because GM, the auto task force, workers, a majority of bondholders and others have worked to ensure critical agreements were reached out of court.

"The restructuring that GM must undergo to emerge as a vibrant company will unfortunately cause many people in Oakland County and across the country to lose their jobs.

Laid-off individuals in our communities will need enhanced unemployment benefits and retraining programs. The administration's plan for impacted workers and communities must include direct support for these laid off workers to help them transition into new jobs. We also need a plan to help businesses and communities cope with lost revenue and investments in new advanced manufacturing to transform Michigan's economy over the long-term.

Here are the facts on buying a car with “so-so” credit

“Just what are my requirements to get approved for a car loan?”

“What if I have a recent repossession on my credit record?”

- This does not have to be a problem.

- Again, this does not have to be a problem.

“How much of a down payment will I need?”

NUGS Calls On President Mills

President John Evans Atta Mills has assured the National Union Ghana Students (NUGS) that Government will continue to interact and dialogue with the union to find ways of addressing issues and concerns that they raise.

President Mills was interacting with executives of the NUGS when they paid a courtesy call on the President at the Castle, Osu in Accra.

He said Government will continue to regard the youth as partners in development since his interaction with young people over the years proves that they have a lot to offer, though they lack experience, which according to him goes with age.

"What they have in abundance is exuber-

ance, highest intellectual potential and capacity and the desire to explore to find out what lies ahead of them. These are the qualities that you need if you want your society to progress", he said. I know your worth and what you can contribute to our dear nation.

The objective of Government, President Mills said, is to ensure that the youth are given quality education adding "this is a knowledge based society and without quality education, we cannot compete".

Touching frequent reforms in the education sector, he said education must always respond to the exigencies of the moment. "So some times, there is the need to make changes to ensure that the educational system keeps abreast with development and is able to respond to the needs of the time". He however stated that changes based on political expediency may not inure to the benefit of society.

The Minister for Communications and former President of NUGS, Mr Haruna Iddrisu, said Government is committed to addressing the core issues of access, relevance and quality generally affecting tertiary education in Ghana. He said President Mills is aware that over 40 % of students do not get access to tertiary education in Ghana.

This, he said, is of great concern to the President. He disclosed that government will, in the course of the year, review policy initiative that will seek to expand access to higher education through massive investment in infrastructure, particularly academic facilities

He announced that Government will commit GHC12.1 million to support the

students' loans scheme. This disbursement will be done under the students' loans trust, with monies released from the Ghana education trust fund.

He also announced that government will review upward the students' loan and will take effect from the 2010 academic year.

Mr Ishmael Tweneboea Kodua President of NUGS said the Union has made significant contributions to the country from the country's independence struggle through the democratization process since its inception about 50 years ago. This, according to Mr Kodua, informs the President's pledged to build a permanent secretariat for the Union.

NUGS, he said, are however convinced of a bright future for the nation, especially in this era of our political system when the youth are given sensitive places to handle in the Government of the country. the Union is also grateful for the initiative by government to ensure the full implementation of the national youth policy, a program that will offer a sense of direction, purpose and hope to the youth.

He regretted that Ghana's educational system, which has undergone 13 reforms since 1951 still, remained more academic, examination centered, authoritarian and divorces the educated from the norms of their society. He also deplored the extent to which the educational system has been given so much political tag.

The NUGS president also urged Government to help with passage of the education bill after consultation with stakeholders to ensure that no Government for stipulated number of years can temper with the country's educational structure.

Mr. Kodua said NUGS will oppose any attempt by political parties or groups to politicize the educational system of Ghana.

Ghana's HIV Prevalence Further Declines From 1.9% To 1.7%

The national HIV prevalence rate has declined from 1.9 per cent in 2007 to 1.7 in 2008, indicating a stabilising condition, Dr Nii Akwei Addo Programme Manager of the National AIDS Control Programme (NACP) said recently.

The highest prevalence level was recorded among the 25 to 29 year group while the least span the 15-19 age group.

HIV prevalence at the regional level ranged from 1.1 per cent in the Northern Region to 4.2 per cent in the Eastern Region.

All regions with the exception of Eastern recorded a decrease in prevalence from 2007 with Greater Accra, Ashanti and Eastern regions recording prevalence of three per cent and above.

Upper West Region recorded the highest decline from 3.3 per cent to 1.6 per cent with Volta, Western and Upper East, witnessing a consistent decline in prevalence since 2006.

Presenting the findings of the HIV Sentinel Survey, conducted in 40 sentinel sites strategically located in 17 rural sites and 23 urban sites, Dr Addo said nearly 95 per cent of HIV positive samples were HIV type I with HIV type II recording 3.8 per cent and dual infection of types I and II was 1.7 per cent of the total positive samples.

The HIV Sentinel Survey is a cross sectional survey targeting pregnant women attending ante natal clinics in selected sites in Ghana. The annual HIV sentinel surveil-

lance system was initiated based on the premise that prevalence of HIV among pregnant women is a good proxy indicator of the spread of infection among the populace.

Dr Addo called for sustained prevention education targeted at the youth and other special groups to ensure further decline in the overall prevalence.

He commended health workers, the Ghana AIDS Commission, Ministry of Health, Ghana Health Service and other donor partners including WHO and DFID for their technical and financial support in ensuring that the HIV prevalence of the country was reduced to its barest minimum and called for more support since "this is the period that we need you most to ensure continuous drop in the prevalence".

Dr George Sipa-Adjah Yankey Minister for Health noted that prevention was the bedrock of the national response and called for behavioural change, Voluntary Counselling and Testing and the expansion of services.

Prof Fred T Sai, Family Health Consultant who presided reiterated the need to intensify efforts in ensuring that the youth were protected.

He noted that any infection over one per cent should be described as a danger which frustrated development and called for political leadership to ensue the raking of the prevalence for its total decrease.

Ghana And EU Signs 76 Million Euro Agreement

Ghana and the European Commission (EC) recently signed a 76 million euro financing agreement to support the rehabilitation of the 94.4 kilometre Tarkwa-Bogoso-Ayamfuri road.

The funds, made available under the Transport Sector Development programme seeks to improve the road network in the timber, mineral and cocoa producing rich west of Ghana with the view of facilitating easy connection to the Takoradi Port in the Western Region.

The Western Region currently provides about 25 percent of national Gross Domestic Product. It will also link Burkina Faso and Cote d'Ivoire as part of the regional integration agenda.

Dr Kwabena Duffour, Minister for Finance and Economic Planning and Mr Guy Samzun, Charge d'affaires of the Delegation of the European Commission in Ghana signed the agreement.

Dr Duffour said road transport infrastructure development is priority of government and is happy that the EC continues to focus on the area for effective development.

He said government and EC must

concentrate development efforts on transport connectivity and integration as one the thematic interventions.

Mr Duffour said construction of the road will properly link the Western, Brong-Ahafo and Central regions to Cote d'Ivoire through Bouake.

He urged the Ghana Highways Authority to keep to the measures announced in the agreement so that good contractors are engaged to handle the projects and complete them on time.

Dr Duffour pledged government commitment to adhere to maintenance and rigorously enforced the axle load requirements to protect the road infrastructure.

Mr Joe Gidisu, Minister for Roads and Highways said the rehabilitation will ease the drudgery of travelling on that stretch of road.

He said the availability of such improved infrastructure will make investors take full advantage of opportunities in other parts of the region.

Mr Samzun said Ghana must seek maximum integration in the planning of the various transport mode projects and programmes in order to derive the maximum benefit from the transport sector.

The Most Dangerous Hospital Technologies

Medical technology can and often does save lives -- but sometimes the unthinkable happens and the device that was supposed to help a patient actually causes harm, perhaps even death. With patient safety rising to the top of the list of hospital priorities, each and every aspect of care is being scrutinized for improvement opportunities, including medical technology. TPN staff recently took a look at a report entitled Top 10 Health Technology Hazards, released by the ECRI Institute, an organization dedicated to improving the quality of health care. Dan Alt, manager of ECRI's problem reporting system, stated that while some problems on the list are related to equipment design, others are caused by human error -- and most are avoidable if hospitals take specific precautions. Alt said the goal is to prevent, not spread, panic.

**What are the dangers on ECRI's list?
Here are the top 10:**

1. Alarms that fail to adequately convey when a patient is in danger. For example, desensitization, improper settings or disabling of alarms put patients at risk if an emergency is not recognized.
2. Needlesticks and other sharp objects. These may expose clinicians (and even patients, though this is highly unusual) to life-threatening pathogens, including HIV.
3. Air embolism from contrast media injectors used in angioplasty. These high-tech power injectors can introduce air

bubbles into the blood vessel, which may cause a dangerous, sometimes even fatal, air embolism.

4. Foreign matter left in patients after surgery.
5. Surgical fires. Fortunately these are quite rare (about 650 a year). Like all fires, surgical fires are caused by an ignition source (for instance, an electrocautery device or a laser) in the presence of supplemental oxygen (for anesthesia) and a fuel source. The complicating factor in surgical fires is that two clinicians are effectively "in control" of two of the factors -- the surgeon of the lasers and electrocautery devices, the anesthesiologist of the oxygen. They must work together to reduce the risk.
6. Anesthesia equipment that hasn't been properly checked prior to each use. This carries the risk of problems like misconnected breathing circuits, ventilator leaks or empty gas cylinders.
7. Misleading patient information displays, which convey ambiguous or confusing data, such as vital signs and airway pressure.
8. CT radiation dose. Exposure to the high radiation levels from CT scans is thought to account for about 6,000 additional cancers each year for patients.
9. Magnetic resonance imaging (MRI) burns. Causes include crossed cables, improperly placed sensors or patient contact with the coils.
10. Fiber-optic light-source burns, typi-

cally caused by inappropriate placement of cables on the patient.

HEALTH CARE IS HIGH RISK

This report was created from information taken from a number of medical reports and resources. (You can see the report at ecri.org.) James Conway, MS, senior vice president of the Institute for Healthcare Improvement (IHI.org), called the findings "sobering" but noted that it is important to remember that "health care is a high-risk industry."

On the positive side, Conway pointed out that the fact that the report even exists is evidence of the new focus on patient safety, which only became a priority in the last decade. He said that hospitals are getting serious about safety issues, setting up groups and committees to deal with issues raised by reports like the one from the ECRI Institute. However, he said his observation is anecdotal and doesn't necessarily represent the majority of hospitals. The idea that patient safety isn't always paramount in the medical field is disconcerting. While patients generally can't do a great deal to eliminate or avoid these high-tech hazards, Conway said forward-looking organizations should welcome input from patients and family members about matters of concern.

WHAT CAN YOU DO?

Conway offered five suggestions to patients to help improve the effectiveness

and safety of their medical treatment...

1. Educate yourself and compare options. I've written often on the importance of evaluating hospital quality data before you decide where to be treated. (See Daily Health News, May 5, 2008, for more information on this vitally important topic.)
 2. Ask questions. If you don't understand something, ask. Bring a list of questions to each visit with your doctor and get precisely detailed answers about the procedures, medications, etc., so you understand exactly what is supposed to happen.
 3. If you see something, say something. As a patient or a visitor, if you notice that something doesn't look right -- a medication that doesn't look like what you've been getting, or a monitor that seems to be acting funny -- speak up.
 4. Never go alone. Bring someone with you for each doctor's visit. They're sure to see or hear things you'll overlook or that you'll forget.
 5. Give -- and demand -- respect. If you aren't satisfied with an answer, respectfully ask to speak to someone else. Or ask the nurse or physician to double-check. You deserve a thorough answer. And getting the answer you deserve can go a long way to making your stay safer.

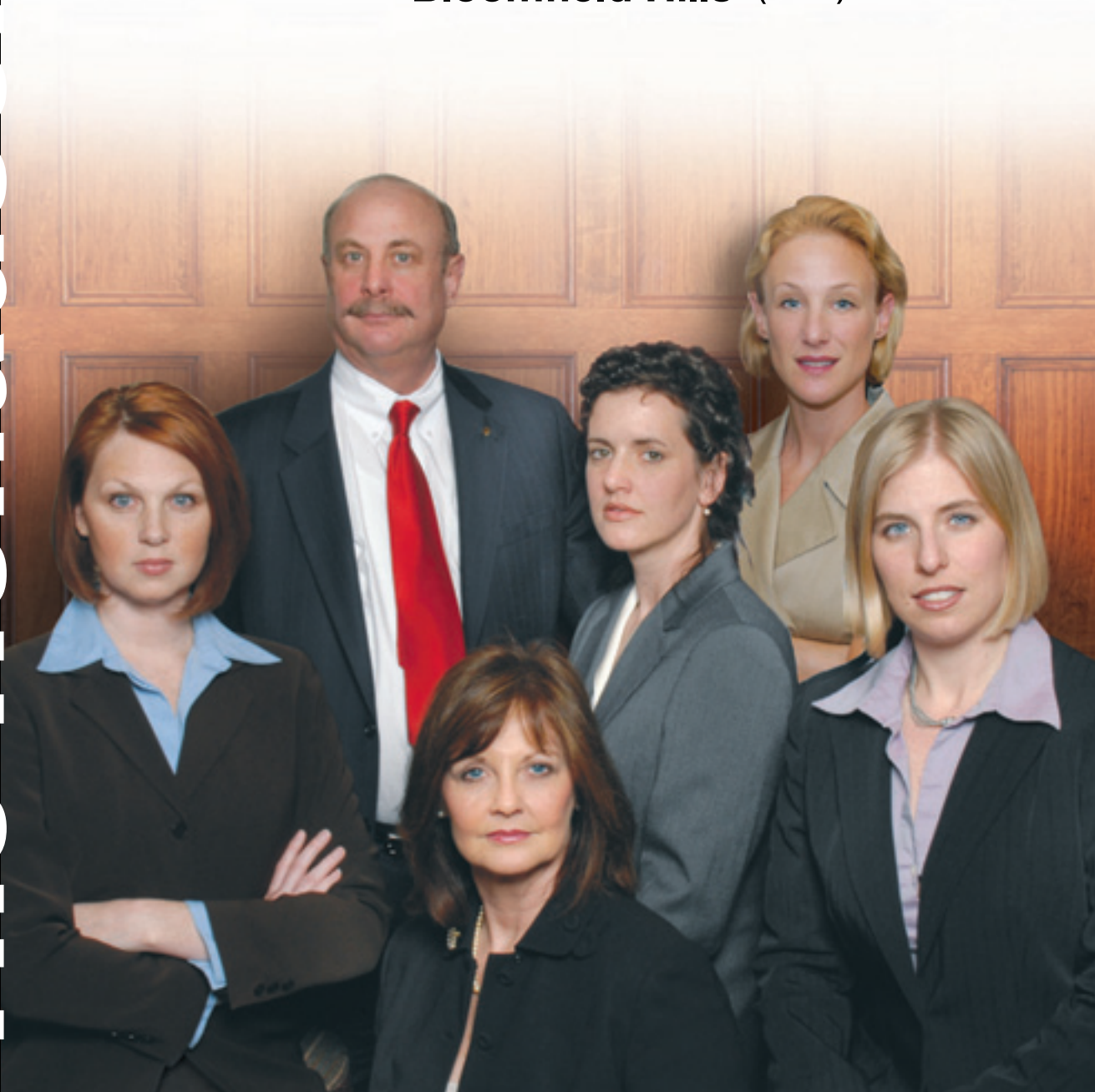

Education Vouchers

Educational vouchers represent a system of education finance in which parents are given a tuition certificate that can be used to attend participating public or private schools. Education vouchers can be paid by public (government) or private (corporations, foundations) funds. Many different kinds of voucher plans have been proposed. Each may address the needs of different students and emphasize different priorities. For example, the dollar amount of a voucher differs considerably among different plans. Also, a voucher can be given to low-income students, to students in failing schools, or to the entire population. However, all publicly-funded voucher programs take funds usually given directly to public schools and allocate them to parents to decide where money for their child's education will be spent.

Why are publicly-funded education vouchers controversial?

Publicly-funded education vouchers allow families to make private decisions regarding how public taxpayer money should be spent. Therefore, a voucher program hopes to create an educational market where schools must compete for students. Supporters claim market benefits, such as choice and innovation, will improve education. Opponents fear that vouchers will lead to greater inequality and the loss of civic preparation. Current evidence concerning the impact of vouchers is disputed. The potential advantages and disadvantages of publicly-funded vouchers are listed below.

What are the possible advantages of publicly-funded vouchers?

- **Increased Choice.** A tuition certificate, especially for low-income families, helps parents afford to choose a school suited to their child's needs.
- **Greater Competition.** As families gain the ability to choose the school their child attends, schools may have to improve to attract students.
- **Targeted Assistance.** Vouchers can be aimed at a particular struggling student population and offer assistance without changing the entire public education system.

- **More Parental Discretion.** Vouchers provide parents with significant authority over the knowledge and skills their child will learn.

What are the possible disadvantages of publicly-funded vouchers?

- **Increased Inequality.** Unregulated markets may produce widely varying quality and school focus.
- **Difficult Implementation.** Many private schools refuse to participate in voucher programs and there may be more interested students than seats available.
- **Administrative Costs May Rise.** New administrative and functional oversight, informational services, and transportation will need to be addressed to run a voucher program. This creates additional costs.
- **Loss of Public Sphere.** If education becomes a private decision of the family, there is little incentive to engage in public discourse and activity.

What was the Zelman decision? Why is it important?

The case Zelman et al. v. Simmons-Harris et al. gained national attention when the Supreme Court declared that vouchers could be used to attend religious schools under specific circumstances. The case concerned the Cleveland Scholarship and Tutoring Program, which provided students with vouchers to attend public and private schools. Nearly all voucher recipients attended religious schools. Voucher opponents insisted the Cleveland program violated the separation of church and state. Defenders of the voucher program claimed

students simply enrolled in the best schools available. For example, 46 of the 56 schools willing to accept vouchers held a religious affiliation. On June 27, 2002, in a 5-4 ruling, the court found that Cleveland's voucher program did not violate the Establishment Clause of the First Amendment and was allowed to continue operation.

The influence of the Zelman decision continues to be debated. Many voucher advocates believe legal acceptance is a crucial step forward in promoting widespread voucher programs. However, legal scholars and educators note that the ruling only applies to federal law. Many state constitutions explicitly prohibit the use of public dollars to fund religious education, which may obstruct future voucher programs.

How large are publicly-funded voucher programs?

Despite the significant attention given to educational vouchers, there are only a few, small voucher programs in existence. Many proposals for voucher programs have met sharp resistance from state legislators and local citizens. At present, only three states have operational voucher programs. A few other states are debating creating a voucher program. The chart below details current voucher programs in the United States as of 2002.

How realistic is the plan to create five million new 'green collar' jobs?

President Obama's plan to turn around the US economy includes \$150bn of investment in green energy over the next ten years, driving America towards energy independence whilst creating 5 million 'green collar' jobs.

Nobody could question the need for the new US president to take action to resurrect the US economy or our need for the US to take a prominent role in the battle against climate change. However, is creating five million renewable energy jobs in the US realistic currently? And if not why not?

According to Wikipedia a 'green collar' worker is someone who is employed in the environmental sectors of the economy. When Obama has talked about green collar jobs in recent times in relation to his New Energy for America Plan he has referred more specifically to jobs within the renewable energy sector and its supply chain.

Today there is a growing skills shortage within the renewable energy sector globally. While many other industries are making redundancies recruiters in the renewable energy markets are currently kept very busy. Many employers within the sector are still

battling with a bottleneck that threatens the growth of their businesses and that of the whole sector. Why is that?

The industry is still in its relative infancy so unlike many other industries there are comparatively few professionals with more than a few years' experience. Over the past 5 years the industry has experienced huge growth and with many countries setting aggressive carbon reduction targets is further growth sustainable or even possible?

It could be argued that the availability of economic capital to simulate growth is not all that's needed, and in fact the availability of human capital could be in reality the limiting factor. The majority of jobs within the alternative energy industry are highly technical and based on engineering or scientific disciplines. Certainly, all growing companies need accountants, lawyers and human resources professionals but these are essentially 'back office' jobs and for every back office job there are five times as many 'front office' jobs: the engineers and technicians that are planning and building wind farms or designing, manufacturing and installing solar panels for example.

In the short term the creation of several million highly technical jobs may be little consolation to the hairdresser, shop manager



or average person in the street who may have recently lost their job through redundancy.

You only need look at a specialist renewable energy job site such as RenewableEnergyJobs.com for confirmation of the global shortage of engineering skills in the sector, but why?

According to a study published in America by the National Academies there are 70,000 engineering graduates each year in the US completing their first degree. Compare that with 600,000 graduating from Chinese universities and 350,000 from India and the problem becomes more apparent. In 2005 Duke University released a revised set of figures which concluded that both the original Chinese and Indian numbers include graduates who have completed 3 and 4 years degrees while the US figures are all based on graduates of the longer 4 year degree. Their revised figures discounted those graduates completing the 3 year course, China still graduated 351,537 engineers with 4 year degrees. That's still five times the US total.

This is not just an American problem, as highlighted in the OECD policy paper "Evolution of Student Interest in Science and Technology Studies" published in 2006: in the past 15 years there has been a decrease in the relative number of graduating engineers in Europe. The problem is even more acute in the UK than in the EU as a whole. The number of engineering graduates, currently around 22,000 per annum, has steadily fallen over the last ten years, from 11% of the annual total of graduates in 1998 to 7% in 2007, despite a rising trend in the number of students at university.

In last year's 'Energy Pulse' survey conducted by Doosan Babcock (the energy services firm), the vast majority of energy experts highlighted the serious lack of skills as a major problem for the energy industry as a whole.

Obama's plan to create 5m renewable energy jobs within 10 years would require hundreds of thousands of jobs to be filled each year. How can this possibly be achieved with such low numbers of engineers graduating through the US educational system?

The plan outlines a goal of retraining America's currently manufacturing workforce to cope with the demands of the low carbon economy, which if achieved, will go some way to solving the US skills shortage however it is going to be a huge challenge and does not solve the fundamental problem.

The western world is currently not producing enough engineers and those who do graduate with technical degree have many career options to choose from such as telecommunications, nanotechnology, computing etc.

In developing countries like India and China engineers are apparently held in far higher regard than in developed countries. This is possibly due to the very obvious impact that large infrastructure projects can have on everyday lives and local communities.

Unless the number of students taking STEM based qualifications in the western world increases dramatically this global skills shortage will become more apparent and more constraining for business. The creation of new jobs is important, but the success of Obama's plans could hinge on our ability to overcome the shortage of suitably qualified personnel both in the US and internationally.

It is widely accepted that in many countries such as the UK there is a distinct lack of qualified teachers across all of the STEM subjects, and at all levels. This needs to be addressed urgently, but additionally we need to address prospective students' perception of the "engineer" brand, tackle our failure to connect with talented students, and actively pursue policies to attract them to STEM related studies at first degree level.

Unless we can tackle the very real issue of available, qualified and appropriately skilled resource, talk of millions of new jobs being filled within the renewable energy sector is, I am afraid, likely to remain somewhat of a pipe dream.

Determining Electricity Consumption of Your Home Appliances

Improving energy efficiency and conservation around the house requires a certain attention to detail. There are a multitude of electronic appliances that populate the modern home. Knowing how many watts of electricity each appliances uses is a key step toward reducing your electricity consumption. You'll know which ones to trade in for newer, more efficient models- creating a general awareness and knowledge that will aide in all of your energy conserving endeavors.

Figuring out how many watts of electricity an appliance uses is typically very easy. It is generally printed right on the device. It will either be stamped on it somewhere or printed on a nameplate that is usually affixed to the back.

If the number of watts is not printed on the device, then look for the current, in amperes (A), and voltage (V). Most appliances, from stereos to toaster ovens, use 120 volts (the maximum voltage for a standard outlet). Larger appliances, such as clothes dryers, may use 240-volt outlets. To find a unit's wattage, simply multiply the amps and the volts. For example, a device drawing 5.0 A at 120 volts is using 600 Watts of electricity.

In the typical home, water heaters use by far the most amount of electricity, drawing 4500-5500 watts when running. The clothes dryer, dishwasher, and vacuum cleaner are also big electricity users. Just remember that an individual appliance's cost to each household is different based on how much the appliance is used. For example, a laptop computer typically uses only 50 W of elec-

tricity (somewhat less in sleep mode) and a dryer may use 5000. But if the computer is left on 24 hours a day, and the dryer is rarely used because you dry your clothes outside on a line, then suddenly the smaller, more efficient computer has the higher cost in electricity. Being energy efficient is as much about lifestyle and the way we use the products we purchase as it is about the products themselves.

Bear in mind that the wattage listed on an electronic device is its peak level of consumption. That is to say that electronics such as stereos, with volume controls, may not be drawing the maximum number of watts at all times. It all depends on the setting.

When evaluating the energy efficiency of any device, it is also important to factor in "phantom" loads, or the small amount of electricity that a device draws, even when it is switched off. Televisions, stereos, computers, all such devices carry phantom loads. These are small amounts but can really add up, especially considering the number of appliances in the average home. To avoid this issue, either unplug appliances when unused, or plug several into a power strip and then switch the strip off when the group is not in commission. The power strip method is an excellent choice for computer desks and home entertainment centers, where all components are typically used or shut off at the same time.

NEW NO FAULT PROBLEMS

Most consumers in the State of Michigan are aware that we are a No Fault State. "No Fault" refers to certain aspects of our automobile insurance. The original statute was introduced in 1973. At that time, the basics of the statute were: a person could not recover for pain, suffering and emotional distress if injuries did not reach a certain threshold. The threshold at the beginning of the application of the statute was: serious, permanent disfigurement and/or serious impairment of necessary body functions. The statute did not define either of those standards with any specificity. Nor were there definitions elsewhere in the statute.

From the beginning, this became problematic. The legislature attempted to solve this problem by adding requirements as opposed to adding definitions. Sometime later, 10 or 15 years after the original statute started, the first two requirements continued plus the injury had to be "objectively manifested". Again, this is not a well defined set of terms. It was easy when one could see a broken bone on an x-ray. It was less easy when a physician could see spasms upon palpating a muscle group. After all, a physician's observations were also objective. The insurance carriers weren't happy about this and put pressure on the legislature and the courts.

Over the years, the situation evolved. In the early 1990s the standard was yet again circumscribed, this time to include the first

two items, e.g. serious, permanent disfigurement and/or serious impairment of necessary body function; the second item: objectively manifested, and a new item: significantly impacting the activities of daily life.

Each of those items became the subject of interpretation in the higher courts of this State.

In 2004, certain members of the Supreme Court of the State of Michigan decided to take it into their own hands to expand the requirement (that is to say, to make it more difficult to recover damages for pain, suffering and emotional distress) by adding yet another level of difficulty. The legislature didn't add this level of difficulty. The Supreme Court added this level of difficulty. The Supreme Court decided that all of the preceding items mentioned in this article had to apply plus the injuries had to "significantly impact the trajectory of a person's life". This is often referred to as "the Kreiner standard".

Many people (including the writer of this article) feel that this standard is wrong. It leads to foolish results. In one of the original cases, a carpenter injured the tendons in one hand. He was hospitalized for days. He had surgery. He was off work for three months. The Supreme Court opined that this was insufficient interference with the trajectory of this person's life. Heaven only knows what that meant to this person's life in the long run. Then, in another case, one of the appellate authorities ruled that an elderly person who was blind and who had had a minor injury but could no longer knit due to her injuries could collect because the trajectory of her life was, indeed, affected. A young carpenter supporting a family could face financial ruin as a result of months off work and he would

be barred from recovery. An elderly person who could not knit for entertainment could recover.

Now the Supreme Court is about to change. There are three justices who have supported Kreiner: Justices Markman, Young and Corrigan. There are three justices who have questioned Kreiner: Justices Cavanaugh, Kelly and Weaver. Justice Taylor, who authored the Kreiner decision is no longer on the Supreme Court, having been

rejected by the voters of the State of Michigan. Shortly we will have a new justice: Diane Hathaway. Many believe that the new makeup of the Court will warrant a re-visit to the Kreiner decision. Many hope that this judge-made law will be revoked.

OCC Commencement Speaker Matt Prentice Urges Graduates To Use Imagination, Seize Opportunities

More than 2,000 students graduated from Oakland Community College, Friday, May 29. Besides the graduates an audience estimated at 6,500, including family members, guests, trustees of the college, faculty and staff took part in OCC's 43rd annual commencement ceremonies at the Palace of Auburn Hills.

Eight hundred and fifteen graduates, close to half of the class of '09, earned university transfer degrees in business, liberal arts and science.

The second highest group, 780, earned Associates of Applied Science Degrees. Also known as "career degrees", these diplomas provide graduates with entry-level credentials in a wide variety of high-demand professions including accounting, robotics and nursing. OCC offers more than 160 programs and options of this type.

The balance of the graduating class was awarded associate degrees in general studies and one-year certificates.

OCC's commencement speaker this year was eminent restaurateur and caterer Matt Prentice, CEO of the Matt Prentice Restaurant Group, who congratulated the graduates on achieving something that circumstances had conspired to keep him from achieving - a college degree.

Mr. Prentice explained that he had been forced to drop out of the prestigious Culinary Institute of America due to diminished funds

and family health problems, but felt that in the ensuing years he had earned a "Master's of Hard Knocks".

Noting that he had hired and mentored hundreds of OCC students over the years, Mr. Prentice went on to praise the OCC Culinary Program and its leadership, stating that he would "rather hire an OCC culinary grad than a graduate of the Culinary Institute of America".

Mr. Prentice briefly recapped the growth of his corporation from the small Oak Park Deli he took over in 1980, to his present operation - nine restaurants, an artisan bread factory/patisserie, five banquet facilities, and one of the state's largest catering operations. The intent of the newly formed Oakland County Senior Planning Coalition is to conduct a needs assessment of Oakland County's aging population. The group will offer recommendations to enhance the quality of life, the business climate, and health and social services safety net for older Oakland County residents. Just as important are the support services for their families and caregivers.

The Oakland County Senior Planning Coalition consists of representatives from the Area Agency on Aging 1-B; Oakland Livingston Human Services Agency; United Way for Southeast Michigan; Catholic Social Services; Oakland County Senior Advisory Council; Oakland County's Health and Human Services Department; and fellow members from the Oakland County Board of Commissioners: Helaine Zack, Marcia Gershenson, Shelley Goodman Taub and Bradford C. Jacobsen, along with representatives from community organizations; senior centers; local government and the general public.

It is believed that in a few short years there will be more citizens in Oakland County aged 65+ than school age children. A presentation will be provided by special guest speaker and expert Kurt Metzger, Director of Research for City Connect Detroit. Metzger will share valuable information on how Oakland County demographics are shifting and look at projections that point to a "Silver Tsunami". He will

look at all facets of the issue from the economic impact, transportation, health, social services, housing to active senior lifestyles.

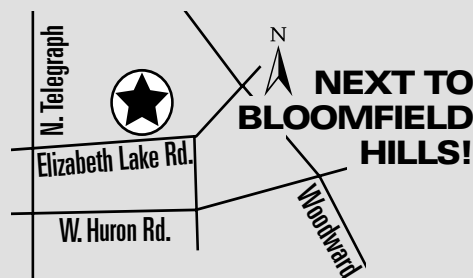
